1. Name of the Society:- Millat Talimi Society, Muzaffarpur
2. Registered Office - Kachisarai Road Muzaffarpur- 842002
3. Aims and objects of the society:-

The name of the society will be Millat Talimi Society Muzaffarpur. This trust is an organisation of the Muslem community of Muzaffarpur in particular and of the entire provinces of India.

(a) It is founded to provide facilities for imparting higher and technical education to the members of Muslim community in particular and to enable them to conserve their religion, culture and language and to learn National and international literatures and modern science and technology and also to acquire physical training and for that purpose to establish a suitable educational institutions.

(b) It also aims at providing all sort of facilities to the intended unemployed persons (men and women both) in earning their livelihood and for that purpose it will organise training camps after getting training they may ask for loan from the society. It will give incentives to youth and children to continue study or improve their qualification and for that purpose scholarship scheme will be introduced.

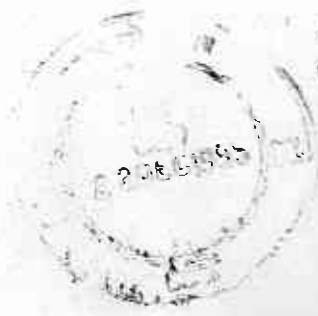
(c) It will also establish clubs, Liabraries and Literery societies and organise annual function in which prizes and certificates will begiven to the winners.

(d) It will set-up a BATTUL-MALL (Charity fund) from which poors, needy and sufferers will be benifited .Unclaimed dead-bodies will be creamated with the help of this fund.
